In consideration of my engagement as a model, and for other good and valuable consideration herein acknowledged as agreed, I hereby grant to Kevin Duda ("Photographer"), his heirs, legal representatives and assigns, successors in interest, those for whom Photographer is acting, and those acting with Photographer's authority and permission, the irrevocable and unrestricted right and permission to copyright, in Photographer's own name or otherwise, and use, re-use, publish, and re-publish any pictures or recordings, including but not limited to any and all visual, audio and other images or impressions, photographs, negatives, slides, video and audio recordings and moving pictures, digital or otherwise, taken of me or in which I may be included, previously or hereafter produced, in whole or in part, or composite or distorted in character or form, without restriction as to changes or alterations, in conjunction with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium, including without limitation film, videotape, electronic copies, prints and any other medium, electronic or otherwise, at Photographer's studios or elsewhere, and in any and all media now or hereafter known for illustration, promotion, art, editorial, advertising, trade, or any other purpose whatsoever.

I hereby waive any right that I may have to inspect or approve the finished product or products and the advertising copy or other matter that may be used in connection therewith or the use to which it may be applied. I understand that Photographer retains all rights to any images or other recordings taken of me and that any copies of such recordings that I might receive are provided solely for my personal or promotional use and not for commercial or for-profit use of any kind, including but not limited to re-selling, licensing, charging for access, or any other methods of profit.

I hereby release, discharge and agree to save harmless Photographer, his heirs, legal representatives and assigns, and all persons acting under Photographer's authority or permission or those for whom he is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said picture, video, or film or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy.

I hereby warrant that I am of full age and have the right to contract in my own name. I state further that I have read the above authorization, release, and agreement, prior to its execution, and I am fully familiar with the contents thereof. This release shall be binding upon me and my heirs, legal representatives, and assigns.
